Genealogy Research 2012

- Start with yourself and your immediate family. Sometimes that's hard enough. Many times family members who don't care where they came from won't help much if at all. Start with a paper and pencil. File folders can also be helpful.
- Branch out to distant relatives. Phone calls emails or letters to an Aunt or Uncle. Look into a very distant relative. 3rd cousin in Texas. A lot of letter writing or emailing. Still paper and pencil unless you want to get a Genealogy Program – Ancestry.com - Family Tree Maker.
- Start searching in Historical Societies. Emails and Letters! Slow but be patient. Also be prepared to pay some money. Either you can join their Society for a nominal fee or you can pay for their services.
- Check to see if you're name was spelled differently hundreds of years ago. My name is Coplin, but my ancestors were Copelind. On my mothers side her grandfather's name was Hyland, but in government records it is also spelled Highland, Hiland, and Hylan. On my father's side his mother's maiden name was Van Hornbeeck. But now the records show it as Hornbeck or Hornback. Also notice the Van was dropped. It can get confusing. The key here is to verify dates closely. When did they come over and from what country?
- Be prepared to step on toes. This occurs when your data doesn't fit the data of someone else. Be prepared to defend yourself. My father was adopted by his aunt. His biological mother was his aunt's sister. He did not find out till he was 69 years old. My father had one half brother and two half sisters. Just imagine how they felt when you change their family tree at the branch. It can be upsetting and can lead to hard feelings. It lead to a heart attack for my dad.
- Internet A great tool once you have hit some roadblocks. Ancestry.com has a website for Union and Confederate descendents. I have a page set up and have found two relatives using the page. They found me. You can also run searches on the web for other persons who are running searches for person with your last name. Fees could be required. Genealogy is still one of the number one moneymakers on the web.

- International If you can find out where your ancestors came from then you can email or write to the towns in that country. It is very slow. And may not be correct. When I type in Coplin or Copelind into the programs it cannot give me an area of the world the name came from.
- Scanner- This can help you if you use a program. Many of the programs today have a section for photos. This can give a face to the voices of the past.
- Take breaks. Don't think you can figure your family tree out in a week. I have been working on my families trees (Three of them) for going on 15 years. I have gotten back to the 1200's on one side and the 1400's on another side of the family. With my current work on my home I have taken a rest. I took a rest from research about 5 years ago. If you don't rest once and awhile you will burn out and stop doing any research at all.
- Lastly Have fun Don't make Family Tree research a job. It is a hobby. If you get good at it you can make it a job – but I for one am not interested in digging around in other peoples problems.
