My name is <your name here> and I live in the (##) district. I am also a member of the Sons of Union Veterans of the Civil War. Our group is dedicated to preserving the memory of those who fought to preserve the Union. We also are interested in maintaining monuments that help educate the public of what happened during the War of the Rebellion. That is why I am asking for your assistance in sponsoring a bill to secure the funds to restore the Missouri Monument at the Vicksburg National Military Park in Vicksburg, Mississippi. The State of Missouri originally paid \$40,000 to have this grand monument constructed and dedicated in October of 1917. One of our camp members attended the rededication ceremony in 2013 for the Iowa Monument. While touring the military park he visited the Missouri Monument. He reported back to the Department of Missouri membership that there are some areas of damage and deterioration to the monument. If not addressed in the near future the monument will need more extensive structural repairs that will increase the cost of restoration.

According to the 2013 Historic Preservation Training Center survey the cost to restore the Missouri Civil War Monument at the Vicksburg National Military Park was estimated to be \$367,650. This monument stands for both those who fought for the Blue and those that fought for the Grey. Missouri had 21 Union units and 15 Confederate units that fought during the Battle of Vicksburg. With this being the 150th anniversary of the last year of the Civil War lets preserve this monument for future generations. If you are interested in helping the Sons in our effort to save this State Monument please contact me and I can get more information to you and your staff. Since the original Missouri Monument dedication was done in 1917, it would be great if our generation could rededicate the monument in 2017. I hope you can help and or guide our efforts in the restoration of this beautiful monument.

WHEREAS, Past Commanders-in-Chief moving to another state without transferring his credentials or having dual membership in a state through which his credentials have not been earned currently is not entitled to such credentials; and,

WHEREAS, Past Commanders-in-Chief are a treasure to our organization and have non-voting status on the Council of Administration; now,

THEREFORE, the Department of Missouri, Sons of Union Veterans of the Civil War, duly meeting in encampment on June 6, 2015 in Jefferson City, Missouri, proposes a change to the National Regulations to add a third paragraph to Chapter II, Article II, Section 1 which states:

"Any Past Commander-in-Chief in good standing who joins or transfers into a Department as a brother or dual brother from another state shall have voting rights in Department encampments and his credentials shall be issued by the department secretary."

New or Transferring Members to the Camp

During our last meeting it was brought to the camp's attention that a few of the local camps are in the process of folding. Asboth Camp has already done so earlier this year. Some of the follow up comments about other camps in the area that may fold concerned me. As the nominee for Camp Commander for 2016 — I wanted to share my concerns for the future of U.S. Grant Camp #68.

I understand the principles that the Sons of Union Veterans of the Civil War promote — FCL. I understand the need for new membership as we struggle to bring new members in to the fold. But what I also understand is that some members can cause friction within a camp or department that make the meetings and the membership almost unbearable. We experienced this first hand in our department and camp. Both paid a price in membership and credibility in both of those situations. I don't want to go into what those situations were but there are those of you here tonight that know what I are talking about.

Here is my concern – members of a camp that folds can apply to transfer to another active can p. Those members of the camp that caused the demise of their previous camp may bring that same friction to their new camp. We have a solid group of dedicated men in Grant Camp and our meetings hav a improved greatly over the years. By allowing a disruptive brother to transfer into our camp — it may lead to a situation in which we return to having limited camp meeting attendance and the loss of mambers.

I propose that a membership committee be formed to screen potential new as well as transfer ing members. We need to work on more background work to make sure new members will fit in with our camp. If a transferring brother wants to join let us do some homework. If I member of our camp has solid proof that a potential transferring brother had major issues in his previous camp or department we need to identify this and either talk with the transferring member of our concerns and let him join or deny his transfer. In the end the camp will vote on approving or denying membership.

Again I thank you for nominating me for the post of Camp Commander for 2016. I have held this post in the past and promise to do my best to keep U.S. Grant Camp #68 strong and the leader of the Department of Missouri.

Badge Sales and Cost

I have noticed over the past year that our costs for the badges we produce have increased while we have not changed our prices to match the change in cost. I would like to proposal to the camp that we increase our badge price to reflect the increase in our costs. I would propose that the change would take effect January 1st 2016. Below you can see our current price structure along with our costs and profit margin.

Current Badge Price

\$9.00 per badge plus \$2.00 for shipping (Up to 3 badges) = \$11.00 For Three badges \$27.00 plus \$2.00 for shipping = \$29.00

Current Badge Cost

\$7.60 per badge plus \$1.90 for shipping one badge + .95 for mailer = \$10.45 <u>Equals a .55 cent profit</u>

For Three badges \$22.80 plus plus \$2.58 for shipping three badges + .95 for mailer = \$26.33 *Equals a \$2.67 profit*

Proposal of Price Change

Increase the per badge price to \$10.50 and the shipping to \$3.00 for up to 3 badges.

\$10.50 per badge plus \$3.00 for shipping (Up to 3 badges) = \$13.50 (Overall increase \$2.50) For Three badges \$31.50 plus \$3.00 for shipping = \$33.50 (Overall increase \$4.50)

Estimated Profit for one badge = \$3.05 Estimated Profit for three badges = \$7.17
