I am writing you in regards to the information I have read in the paper and on line about the efforts to remove the Confederate Memorial that is currently in Forest Park. It stands as a reminder of the past. And that is all it stands for - the past. The idea behind the monument was defeated by the Boys in Blue. We can't change history - our nation fought a War of the Rebellion from 1861-1865. The outcome of that Rebellion freed those that were held in bondage. I can understand the point of those who wish to see it be dismantled and put somewhere else - but at what cost? When I read the figure of over \$120,000 in the paper I was rather taken back. That is a lot of money to hide the past. The funds that could be spent on removing the monument could instead be spent in other ways to promote healing in the area. It was mentioned in one article that an interpretive plaque should be put in front or next to the monument where ever it ends up – place that plaque where the monument currently stands.


Senior Vice Commander report – request pray for Granddaughter 'Harper' due to leukemia.

  - d. Federal soldiers tortured Jesse James's stepfather at the James Farm in this Missouri town. The act led James to vow revenge on the Union. James is buried in nearby Mount Olivet Cemetery.
  - e. The Second Battle of this Missouri town was the final gasp of the Confederacy in Missouri. At this time, General Price was being run out of the state after his famous, but unsuccessful, raid. This was the last major Civil War battle fought west of the Mississippi River.

Whereas, the National Organization, Sons of Union Veterans of the Civil War, has applied for 501c3 status and has a need to increase the amount of charitable contributions above and beyond current levels in order to satisfy the Internal Revenue Service.

Whereas, "Preservation" is a key element of the SUVCW brand, and specifically, battlefield preservation is a key preservation initiative under the Vision 2020 strategic plan.
