

White Haven Debate - 06 November 1999

On November 6, Mark Coplin, Don Palmer and Dwight Prade of the U.S. Grant Camp participated in a debate held at White Haven (sponsored by the U.S. Grant National Historic Site). The subject of the debate was Ulysses S. Grant and the Civil War. Also participating was Tom Hubert of the Sons of Confiederate Veterans (SCV) and Jack Powell and Don Waldemer from the Civil War Round Table of St. Louis (CWRT). The program consisted of three "mini-debates", two of which included the Sons of Union Veterans (SUV). The first mini-debate contested between the SUV and the SCV focused on Grant and Robert E. Lee and their respective greatness as generals. Don Palmer presented the case for Grant and Mark Coplin provided the rebuttal on the issue of Lee. The third mini-debate, contested between the SUV and CWRT centered on the issue of whether Grant was essential to the Union victory. Dwight Prade presented the rebuttal on the case made by the CWRT. The second debate, contested between the SCV and CWRT focused on the question of which battle, Vicksburg or Gettysburg, had the greatest impact on the outcome of the war. After the debate, questions firom the audience of about 40 visitors were entertained. The feedback from the audience and the staff at the U.S. Grant Historic Site was very positive.


May 3 Camp Meeting

Camp Travel Guide

Fort Clinch State Park

The Civil War in Florida? Actually there are several Civil War sites in Florida. Commander Palmer, during his holiday vacation in Florida, had an opportunity to visit Fort Clinch State Park near Jacksonville, FL. This fort was one of the "Third System of Fortifications" built during the 19th century for coastal defenses. Fort Clinch was named after General Duncan Lamont Clinch, an important figure in Florida's Seminole War of the 1830's. Construction of the fort began in 1847. By 1860, only two bastions and one-third of the brick wall were completed. The ramparts were in place and the guardhouse and prison finished. The lumber sheds, storehouse and kitchens were in various stages of completion; however, not a single cannon had been placed in position. With no federal garrison present, Confederate militia quietly took possession of the fort at the beginning of 1861. They did no work on the fort, but rather established batteries in the fort, the town of Fernandina, and strategic locations on Amelia and Cumberland Islands. Union forces advancing along several South Carolina and Georgia coastal islands in early 1862 caused General Robert E. Lee to authorize a withdrawal from the area. On 03 March 1862, the evacuation was completed,

even as fiederal gunboats and troops arrived to re-establish Union control of Fort Clinch. Units of the 1st New York Volunteer Engineers quickly began a push to complete the fort.

The advent of the rifled barrel cannon ended the era of stone and brick fortifications. Firing heavier shot, with greater accuracy and higher velocity, these new weapons breached the walls of Savannah's Fort Pulaski on 10 April 1862. Nevertheless, continuing efforts led to the near completion of Fort Clinch until 1867, when work at the fort was halted and the post was deactivated.

Fort Clinch was pressed into service during the Spanish-American War in 1898, and one final time during World War II. The Coast Guard, in a joint operation with the Army and Navy, established and maintained a surveillance and communication system within the fort and along various coastal islands in the area.

Today, Fort Clinch stands as one of the finest examples of Third System Fortifications now in existence, and is listed on the National register of Historic Places.

Camp Orders

Series 2000, Number 1

- 1. In order to continue the positive directions the U.S. Grant Camp has taken since its charter was granted in 1996, several short term and long term goals and objectives were established. These shall be used to measure the performance of the camp in 2000 and out years.
- 2. At the end of 1999, the U.S. Grant Camp membership stood at 22 members (73% Member, 18% Associate Member and 9% Junior). A short-term goal has been established to increase the membership ranks to 30 by the end of 2000. A long-term goal was established to triple the 1999 membership level by the end of 2004. The Camp Junior Vice Commander shall develop a plan to accomplish this.
- 3. In order to increase member attendance at camp meetings, a guest speaker program will be established to enrich the meetings and provide educational opportunities for camp members. This program shall be developed by the Camp Senior Vice Commander.
- 4. A goal shall be established to increase interaction with other SUVCW camps and Allied Orders. We are all working towards common goals and, with a renewed spirit of cooperation, more ground can be covered in a shorter period of time.
- 5. The Camp has undertaken many admirable tasks over the past several years. This needs to be conveyed to the department and national organizations on a regular basis. This also needs to be conveyed to the general public. A goal has been

established for regular reporting of camp activities to the Department Senior Vice Commander for incorporation into the BANNER. A goal has also been established to ensure camp activities receive coverage in local newspapers, radio and or television news. The Camp Senior Vice Commander shall be instrumental in seeing that this goal is accomplished.

- 6. Camp meetings will follow (as close as possible) the Rituals of the Order. Camp officers will attend meetings in formal attire (if possible) with membership badges. Camp members may attend in casual dress; however, it is requested that members wear membership badges to the meetings.
- 7. Several Camp Committees shall be established to enhance the conduct of camp business. These committees include: (1) Graves Registration, (2) GAR/Civil War Monuments, (3) Camp Merchandise, (4) Camp Web Site and (5) External Relations. Chairmen of these committees shall be appointed at a later date.
- 8. It is the Commander's sincerest hope that all members find their association with the Order enjoyable and rewarding. It is requested that members supply feedback from time to time so that continuous improvement can be realized.

Department Orders

Series 1999-2000, Number 2

- 1. It has been nearly a full quarter since the 25 September joint meeting between the Missouri and Kansas Departments near Austin, MO. A second joint meeting on 27 November has also come and gone. The attendance by members of Missouri's camps has been excellent, and a wide range of ideas has been established for the 2001 National Encampment. In fact, some of the ideas are so unique that it has been decided to omit mention of any details until the Lansing National Encampment plans are fully published. The next 2001 planning meeting will be on 25 March 2000 in either Wichita or Topeka, KS.
- 2. A seed fund will be necessary to finance the purchase of raffle items for the 2001 National Encampment. At the Missouri Department's June 1999 meeting, members agreed to a \$20 bond (hereafter described as a Loyalty Bond), which will be designated exclusively for this seed fund. Missouri Department members may voluntarily contribute money and obtain a Loyalty Bond. All camps are asked to maintain a register with the name and address of camp members who purchase Loyalty Bonds, and forward a copy of the register and money to the Missouri Department Commander. The Department Commander will then issue a certificate in the name of each SUVCW member who contributed money for a Loyalty Bond. At the conclusion of business for the 2001 National Encampment, this bond will be redeemed; the money will return to the camp to which each bond holder belongs, and the money will be used as a partial payment of each Loyalty Bond

holder's 2002 annual dues. Please consider contributing \$20 for a Loyalty Bond. Every member now has an opportunity to contribute actively to the success of the SUVCW 2001 National Encampment.

- 3. Department staff since the recent reorganization are as follows: Commander John Rutherford, Senior Vice Commander Vern Stottlemyre, Junior Vice Commander John Martin, Secretary-Treasurer Bob Petrovic, Council John Pillers, Bud Marks and Zac Caldwell, Counselor Bob Amsler, Assistant Secretary Jeff Patrick, Assistant Treasurer Mark Coplin and Patriotic Instructor Don Palmer.
- 4. The National organization has queried the Missouri Department regarding our next Department Encampment and elections. After discussion with Missouri Department members who attended the joint meeting on 27 November, it was decided to hold the Missouri Department Encampment and officer elections on 10 June 2000.
- 5. This is a reminder to camp officers and Missouri Department members. A \$2 increase in the national per capita tax will begin on 01 January 2000, so please make a note of this when calling upon membership for dues (also known as "per capita tax").
- 6. Two Camp per capita tax forms are included for the quarter ending 31 December 1999. Also included are two copies of camp officer installation forms. Please return one copy of each form with the appropriate fees to Department Secretary-Treasurer Bob Petrovic on or before 31 December 1999. Also

included is a copy listing the Department of Missouri staff.

- 8. Department business is at a point where some things should be discussed very soon. For this reason, I call upon all Missouri Department members to attend a Missouri Department meeting on 26 February 2000. Since most Missouri Department members prefer Columbia, Missouri as the central meeting location, the next meeting will be held in Columbia. A map locating the precise location of the meeting site will be sent to membersat-large and camps in January. Of course, the weather will unseasonably sunny and warm for this meeting, so I hope to see many Missouri Department members attending this meeting.
